Highlights of the 2014 report include the following:

- The MPSC awarded nearly \$90 million in grants for low-income energy assistance to various organizations. The grants provide immediate assistance for heating needs as well as longer-term assistance in reducing future heating costs for low-income and senior citizens.
- The Commission extended its consumer outreach efforts by attending 75 events throughout the state, ranging from utility sponsored Customer Assistance Days to fairs. The Commission continues to make its Commission meetings available via podcast, handling 17,208 consumer contacts and assisting consumers and businesses with more than 9,924 electric and natural gas complaints and inquiries; 2,171 telecommunications complaints and inquiries; and 1,574 video/cable complaints and inquiries.
- The Commission in 2014 issued 455 orders, consisting of 93 telecommunications, 303 electric, 55 natural gas orders, and four motor carrier orders.
- The Commission also revised the retail natural gas rates of Northern States Power Company and approved the transfer of ownership and control of Upper Peninsula Power Company from Integrys Energy Group to Balfour Beatty Infrastructure Partners, L.P.
- The Commission undertook a series of process improvement initiatives, including streamlining the processing of for-hire motor carrier applications for intrastate authority, upgrading the intrastate telecommunications service provider database and software, and updating the MPSC scorecard, a record of the Commission's performance on key indicators.

MPSC: Gladwin County Latest to Earn “Connected” Broadband Certification in Michigan |

March 11, 2015 - The Michigan Public Service Commission (“MPSC”) today commended Gladwin County for becoming the latest Michigan community to be certified as a "connected" community that has developed a broadband and technology plan to expand broadband access, adoption and use.

"Gladwin County is the 12th community in the state to earn this designation," said Commissioner Sally Talberg. "It is now part of the elite group of Michigan communities that have completed the broadband certification process. These 'connected' communities understand that their success includes access to reliable high-speed networks, digital literacy of residents and the use of online resources locally for business, agriculture, government, and leisure."

The Gladwin County broadband initiative team worked with Connect Michigan to assess the local broadband landscape, identify gaps and establish actionable goals and objectives. It developed a technology action plan with seven priorities: developing a technology mentorship program; performing an analysis of local policies and ordinances; pursuing next generation 911 upgrades; completing a vertical assets inventory; facilitating Internet safety classes; identifying, mapping, and validating broadband demand; and developing or identifying a broadband training and awareness program for small and medium size businesses.

Gladwin County joins Harbor, Inc. (Emmet County), Marquette, Charlevoix, Antrim, St. Clair, Roscommon, Livingston, Mecosta, Clare, Otsego, and Ogemaw counties to earn this distinction in Michigan.

Connect Michigan <<http://www.connectmi.org/>> is a public-private partnership between the Michigan Public Service Commission and Connected Nation to work with local governments, businesses, and citizens in the goal of increasing broadband access, adoption and use. On March 10, 2015, the Michigan Public Service Commission (“Commission”) issued an Order rescinding the license of The Winn Telephone Company to provide basic local exchange service in the State of Michigan. In 2008, The Winn Telephone Company transferred the assets it used to provide local exchange service to its wholly owned subsidiary, Winn Restructuring, Inc., which was granted a license by the Commission on December 4, 2007, in Case No. U-15368. The customers of The Winn Telephone Company became the customers of Winn Restructuring, Inc., which was later renamed Winn Telephone Company. Winn Telephone Company is currently licensed and providing service to all customers and service areas previously served by The Winn Telephone Company. On February 4, 2015, The Winn Telephone Company filed an application requesting to surrender its license to provide basic local exchange service and stated that it no longer provides such services and has no customers.

Michigan Exchange Carriers Association, Inc. (Chippewa County Telephone Company)

On March 10, 2015, the Michigan Public Service Commission (“Commission”) issued an Order authorizing the relinquishment of Chippewa County Telephone Company’s designation as an Eligible Telecommunications Carrier (“ETC”). Chippewa County Telephone Company was originally designated an ETC in conjunction with other members of the Michigan Exchange Carriers Association, Inc. on November 27, 1997. On February 26, 2015, Chippewa County Telephone Company filed an application requesting to relinquish its ETC designation. The Application stated that Chippewa County Telephone Company no longer provides services to any customers. The 12 Lifeline customers that Chippewa County Telephone Company previously had were transferred to Hiawatha Telephone Company effective January 1, 2015, and they continue to receive their Lifeline discounts.

On February 23, 2015, CenturyTel Acquisition LLC informed the Commission of its intent to surrender the license and stated that, pursuant to a corporate reorganization, it has no customers in the state of Michigan.

On February 17, 2015, Nexus Communications, Inc. filed, with the Commission, a Notice of Relinquishment of its Wireline Eligible Telecommunications Carrier Designation in the State of Michigan, Effective as of May 1, 2015.

Multiline Telephone Systems - Rulemaking

On March 10, 2015 the Michigan Public Service Commission (“Commission”) issued an Order adopting revisions to the Commission’s Rules governing multiline telephone systems and the responsibilities of telephone system operators regarding the installation of equipment and software necessary to provide specific location information for a 9-1-1 call, R 484.903. The revisions lower the threshold for the size of buildings in which an operator would be responsible for providing Automatic Location Identification (“ALI”) and Automatic Number Identification (“ANI”) of the specific location of an extension on a multi-line telephone system to the appropriate 9-1-1 Public Service Answering Point (“PSAP”) from a 40,000 square-foot building to a 7,000 square-foot building. On January 13, 2015, the Commission opened a rulemaking proceeding and invited interested persons to appear and make statements and comments regarding these rule revisions.

Two commenters appeared at a public hearing on the matter, and on behalf of the State 9-1-1 Committee (“SNC”) spoke in support of the proposed rule change. The Michigan Department of the Attorney General also submitted written comments on behalf of the SNC in support of the rule change. The Michigan Communication Directors Association (“MCDA”) also submitted comments in support of the proposed rule change.

MiCTA submitted comments opposing the proposed rule change. MiCTA described itself as an association of non-profit colleges, universities, K-12 school systems, state and local governmental units, health care providers, and other non-profit entities. MiCTA stated in its Comments that the change would have the effect of imposing new requirements on small businesses and MiCTA members that are not subject to the rule as it is currently written. MiCTA states that the change – making the rule clearly applicable to occupied areas of 7,000 square feet, rather than 40,000 square feet – imposes onerous expenses on small businesses and non-profits. MiCTA notes that the MLTS statute does not take effect until December 31, 2016, and contends that “Because the rules are not yet effective, any proposed changes are merely speculative, since the Commission has no idea whether or not the implementation of the rules will be effective.” MiCTA comments, p. 5.

The Commission adopted the proposed rule changes noting that “[t]hrough the statute is applicable to all such users, the SNC and the Commission are concerned that the space designations contained in the current R 484.903 may cause some covered MLTS users to think that they need not install the required equipment because the size or layout of their building(s) is excluded from the definitions of covered spaces included in Rule 3(2)-(5).

The revised Rules will now be submitted to the Legislative Service Bureau and the Office of Regulatory Reinvention for their formal approvals.

On March 6, 2015, Mark P. Donaldson and Peggy Hampel, of Roscommon, Michigan, filed a formal Complaint with the Michigan Public Service Commission against Custom Software, Inc., Kirtland Community College, Frontier, Frontier North, Verizon Wireless, and Connect Michigan, Inc. According to the Complaint, Mr. Donaldson and Ms. Hampel (the “Complainants”) allege that the above-listed providers failed to provide notice to and gain allegedly requisite approvals from various municipalities prior to offering telecommunications services. The Complainants also allege that the providers have an obligation to provide free service to municipalities in the areas they are serving. The Complainants request that the Commission impose fines, order various parties to provide them with information, and order the providers to provide free services to the municipalities where they offer services.
