Thomson Reuters will analyze the findings from The Legal's 20th annual managing partners survey, compare them

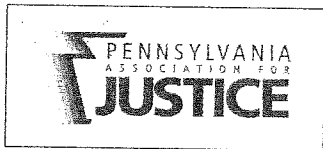
to national trends and give insights on what lies ahead for the Pennsylvania legal market in 2016.
