. . . The MPSC on Sept. 25, 2014 sought permission from the Office of Regulatory Reinvention (“ORR”) to revise the rule (R 484.903), which ORR approved on Oct. 2, 2014. The MPSC submitted the draft rules to ORR and the Legislative Service Bureau (“LSB”) for informal approvals, which were granted on Oct. 2 and Oct. 29, 2014, respectively.

The MPSC on Feb. 12 held a public hearing on the proposed rule revision and on March 10 approved the revised rule and submitted it to ORR and LSB for their formal approvals, which were granted on May 4 and April 29, respectively.

On May 4, the rule was filed with the Joint Committee on Administrative Rules, which did not object to it. The MPSC, therefore, has the authority to formally adopt the revised rule.

The rule was adopted in Case No. U-17721.

**Chippewa County Telephone Company**

On June 15, 2015, the Michigan Public Service Commission (“Commission”) issued an Order rescinding the license of Chippewa County Telephone Company to provide basic local exchange service in Michigan. In 2014, pursuant to a merger, Chippewa County Telephone Company transferred the assets it used to provide basic local exchange service to its affiliate, Hiawatha Telephone Company, which was granted a permanent license to provide basic local exchange service in the Brimley exchange in the November 24, 2014 Commission Order in Case No. U-17706. On June 4, 2015, Chippewa County Telephone Company informed the Commission of its intent to surrender its license, as the company no longer provides basic local exchange service and its former customers are now being served by Hiawatha Telephone Company.

The Commission revoked the designation, “in view of the fact that Osirus has not applied for ETC re-certification since 2010, has never received a SAC, has not constructed a network in the unserved area, has not provided service in the designated area, and has failed to respond to multiple requests by the Staff.”
